WHEREAS, the second lowest numerical bid was submitted by Mark Construction, Inc. in the base bid amount of two million one hundred thirty-eight thousand dollars (\$2,138,000.00), plus seven thousand dollars (\$7,000.00) for ALT-1, plus sixty-two thousand dollars (\$62,000.00) for ALT-2, plus zero dollars (\$0.00)/ "No Change" for ALT-3, plus twenty-eight thousand dollars (\$28,000.00) for ALT-4, plus thirty-one thousand dollars (\$31,000.00) for ALT-5. Mark Construction's bid amounts also included various allowances to be used for unforeseen conditions and for other work the Board deems appropriate for this Project with the requirement that all unused allowance money will be credited back to the Board at the conclusion of the Project; and.

WHEREAS, the Board Architect has reviewed the bid submissions and has recommended that it is in the best interest of the Board to award a contract for the base bid amount as well as all of the alternates (ALT-1, ALT-2, ALT-4 and ALT-5) except ALT-3; and

WHEREAS, the Board has determined that Mark Construction, Inc., 81 Lester Street, Suite 2, Wallington, NJ 07057 to be the lowest responsive and responsible bidder.
